Nonprofit Agreements & Understandings

What we do: Through our Community Outreach Program, Katie Grace Foundation creates relationships with both Community Sponsors and Nonprofit Partners to ensure that underserved members of our community receive the resources that they need.

Who We Help: Nonprofit Organizations who have an active approved EIN with a mission to support the community are eligible to be a KTGF *Nonprofit Partner*. Individually, we support organizations who serve: Title 1 schools, our Veterans, persons recovering from substance abuse and homelessness, survivors of domestic violence or sex trafficking, animal shelters and pet rescues. If you are unsure if our program is right for your organization, just ask! We are always searching for ways to help, perhaps your organization would be a good fit.

How We Help: As an organization, Katie Grace Foundation partners with local warehouse *Community Sponsors*. These Community Sponsors donate their product to Katie Grace Foundation as a conduit to the community. We then create relationships with Nonprofit Partners who can benefit from these donations. From this established relationship, Nonprofit Partners can request online items that their organization needs. Katie Grace Foundation fulfills those requests as they arrive in our warehouse and Nonprofit Partners pick up the items upon notice. It is then up to the Nonprofit Partners to coordinate delivery through their organization to the rightful person in need.

Systems: Once a Nonprofit Partner is approved, they have the ability to request items for their organizations via the [Request Form](#). All parts of the form must be completed in its entirety, including contact information, EIN, and quantity of items needed, understanding that there is a 5 business day expectation. Given that our Community Outreach Program operates as a donation based program, some items may not be available depending on Community Sponsor availability.

Expectations: We expect that our Nonprofit Partners are good stewards of the items received and give credit to Katie Grace Foundation when appropriate. We expect our professional working relationship to be one of respect and reciprocal admiration as Katie Grace Foundation, Community Sponsors, and Nonprofit Partners all operate with the same intention: to support our underserved community.

A Final Note: We are grateful for our Community Sponsors who make possible our ability to donate and support our Nonprofit Partners. In order to maintain relationships with our Community Sponsors, we agree to be good stewards of their product, ensuring that our items are used as they are intended. This means, we expect Nonprofit Partners to give as they promise to support community members who need them and agree not to resell any items for financial gain. There are instances that we can support your organization through donating auction items for a fundraising event, but that must be a forthcoming and honest request.

To Become a Nonprofit Partner

To become a Community Outreach Nonprofit Partner you must complete and submit a New *Nonprofit Application*, which will include your organization's logo, and demographic information for your nonprofit.
